Two vendors were reviewed, Star Entertainment and Onesti Entertainment. Based on the responses and meetings with businesses and past vendors, the committee recommended Onesti. The contract was completed and signed in January 2018. The committee will continue to work with Onesti on entertainment, food vendors, merchandise, etc. To date, two scheduled payments based on terms have been fulfilled by Onesti. The Festa will take place for four days August 16 to August 19.
